


2023 IRRIGATION SEASON OVERVIEW

IMPORTANT ANNOUNCEMENTS

INTER-DISTRICT WATER TRANSFER POLICY - Because the 2023 irrigation year was not declared as a dry or critical water year, allocation transfer from parcel to parcel will not be allowed.

ALLOCATION START - Allocation will start on June 1, 2023 or when Camp Far West Reservoir stops spilling. Inflow into Camp Far West is very dependent on snowmelt from the northern part of the watershed and can vary depending on what upstream water diverters are doing. District staff is working closely with Nevada Irrigation District to monitor upstream reservoir levels, snowpack conditions, inflows, and outflows in an effort to project Camp Far West water conditions.

REMOTE TRACKER PROGRAM - 2023 marks the 2nd year of the District's new water accounting system. Remote Tracker allows water tenders to input grower's flows into laptops that relay that information back to office staff in real time. Additionally, growers have the ability to go online and track their water usage throughout the season.

NOTE: 2023 is only the second year of this program and District staff is still working on optimizing the accounting system.


WATER SUPPLY OUTLOOK

The 2023 water season did not start off as many people were hoping. With drier than average conditions in October and November, it seemed as if California could be in store for another drought year. Having just experienced 3 consecutive drought years, things were not looking good for California water users.


Fortunately, things took a positive turn in December and January as the state saw record rain and snowfall. The rain gauge at Camp Far West Reservoir recorded just over 29" of rain since November 2022.

The snowpack in the Northern Sierra's is 221% of normal for the beginning of May, and is 154% normal for the April 1st average.

These wet hydrological conditions have allowed SSWD to set an allocation of 2.0 AF/Acre for the first time since 2019.

A WORD FROM THE GM

It has been an exciting first year as the new General Manager. Going from severe drought conditions to flood conditions in a matter of weeks provided a short and rapidly changing offseason. Out in the field—jobs were getting planned one day, only to be cancelled two days later due to the most recent storm. In the office, we have been systemically reworking the Remote Tracker Program from top to bottom after our pilot year last season— in an effort to ensure we are providing accurate data to our water users. 2023 marks the first year that SSWD will be operating the powerhouse on Camp Far West Reservoir after taking over operational responsibilities from SMUD—the previous operators since 1986.

One of my main focuses in my first year has been modernization—I want to increase our ability as a water district to provide our customers with a consistent and accurate experience with a quality of service they can come to expect. One part of that equation is upgrading our infrastructure and technology. In January of 2023, the District was awarded a USBR Water Smart grant to replace our main radial gate at the Diversion Dam with several Rubicon gates that will not only maintain their own water level, but will tell the office and dam tender—in real time exactly what flow we are sending down our main canal to our customers. This project is scheduled for Fall of 2023. We have more projects like this planned for the coming years—with several of them to start in the 2023 water season.

I owe a huge thank you to the staff that I have behind me. It is largely due to them that SSWD is able to implement these projects and keep them headed down a path of success. Despite the many challenges we've faced on all fronts over the last 10 months, every team member stayed focused and determined with the end goal of improving the District in mind. It is because of each and every one of them that we have been able to get so much done in a short amount of time.

We are poised to have a good water year, and it is exciting to see all the equipment rolling throughout the District. Please do not hesitate to contact the office if you have any questions or concerns.
